Bidders List.

The bidders list will be comprised of respondents to RFQ-NFC-03-2024 for prequalified contractor status with NFC, who respond by the deadline for RFQ responses as listed in the RFQ Schedule and who successfully meet the criteria for prequalification with NFC as listed in the RFQ-NFC-03-2024 Specifications Document inclusive of any and all addenda.

Start Date for Construction.

Contractors applying for prequalification with NFC must provide a statement with their response affirming the Contractor's willingness to enter into contract with NFC within ten days of notice of an award of bid. Contractors must be prequalified through the RFQ process to be able to submit a bid for the project. At the time of the bid award, the successful bidder will enter into contract immediately, within ten days of notice of award for the project, however, the <u>notice to proceed</u> with construction will be a time mutually agreed upon by the successful bidder and the College, and which will accommodate completion of the project within the funding requirement completion date.

Limits or types of coverage may be increased by the College depending on the scope of work of any project or at any time based upon the recommendation of the College's Risk Management Consortium. The insurance shall cover the

Contractor's entire operations under an agreement with the College and shall be effective throughout the effective period an agreement or any subsequent agreement. It is not the intent of this schedule to limit the types of insurance otherwise required or that the Contractor may desire to obtain.

Proof of insurance at the required levels must be submitted with the RFQ response. Proof of insurance at the required levels for a project may also be requested to be submitted with responses to a competitive solicitation. At the time of competitive solicitation award and prior to any work being done, the Contractor shall submit a certificate of insurance at the required levels with North Florida College included as additional named insured on each applicable policy, and each policy shall include a provision of 30 days written notice to the College of cancellation prior to the expiration date of the policy.
